





EBITDA MARGIN BY SECTOR




SPECIALTY DISTRIBUTION PUBLIC COMPANY BENCHMARKING BY SECTOR








NUMBER OF SPECIALTY DISTRIBUTION TRANSACTIONS BY QUARTER




PERCENT OF TRANSACTION VOLUME COMPLETED BY QUARTER
